

**CENEX Zip Trip® 2022 Dog Days of Summer Gas Giveaway**  
**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN.**

**ELIGIBILITY:** The Cenex Zip Trip® Dog Days of Summer Gas Giveaway (the “Sweepstakes”) is open and offered only to legal US residents of the United States and D.C. (excluding New York, Rhode Island and Florida), who are twenty-one (21) or older at the time of entry. Employees, officers, and directors of Sponsor, its affiliated companies, subsidiaries, franchisees, distributors, dealers, advertising and promotion agencies, and any and all other entities associated with this Sweepstakes (“Released Parties”), and the immediate family members and members of the same household of any of the above are not eligible to participate. **Void where prohibited by law.**

**AGREEMENT TO OFFICIAL RULES:** By participating, Entrants (“Entrants”) agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. **TO ENTER:** Visit any participating Cenex Zip Trip® retail location and scan the “Enter to Win” QR barcode on -promotional materials located throughout the retail location, for entrance to the Sweepstakes. Sweepstakes entry begins at the open of the applicable retail location on Monday, **July 18, 2022** and ends at close of the applicable retail location on Monday, **September 5, 2022** (“Sweepstakes Period”).

**Limit one (1) entry per visit per location per day, except as otherwise indicated. Double entry days will be offered on the following Tuesdays: July 26<sup>th</sup>, August 2<sup>nd</sup>, August 9<sup>th</sup>, August 16<sup>th</sup>, August 23<sup>rd</sup>, August 30<sup>th</sup>, 2022.** Sponsor reserves the right to disqualify any person who submits more than the maximum allowed entries. Released Parties are not responsible for: lost, late, incomplete, invalid, unintelligible, illegible, misdirected or stolen entries. All entries become the exclusive property of Sponsor and will not be acknowledged or returned. By participating, you consent for Sponsor to obtain, use, and transfer your name, address and other information for the purpose of administering this Sweepstakes and for other purposes as set forth below. Entries submitted in any manner which do not conform to these terms will be deemed ineligible.

**DRAWING AND NOTIFICATION:** The winners of prizes will be selected by random draw following each 7-day period during the Sweepstakes Period with a final drawing at the end of the Sweepstakes Period, as outlined below. The first drawing will be held shortly after July 25, 2022 from all eligible entries received through the end of July 24, 2022. The first person selected will be the potential winner of the first prize available for the drawing period, and each subsequent prize will be awarded in the order of the potential winner selected until all prizes for the drawing period are awarded. The remaining weekly drawings will be held in the same manner shortly following August 1 from eligible entries received through July 31, August 8 from eligible entries received through August 7, August 15 from eligible entries received through August 14, August 22 from eligible entries received through August 21, August 29, from eligible entries received through August 28, with final drawing period for grand prize gas card being held shortly after September 6<sup>th</sup> from eligible entries received through September 5<sup>th</sup>, 2022. Eligible entries which are not selected as a weekly winner during any given drawing period will rollover into the entry pool for each subsequent drawing.

The odds of winning any prize offered will depend upon the total number of eligible entries received during the applicable drawing period as outlined above.
